## MEMBERSHIP POLICY FOR RUSTENBURG CPF

# MEMBERSHIP POLICY

1. Members of the Rustenburg CPF shall render their services on a voluntary basis and shall have no claim to compensation solely for services rendered to the Rustenburg CPF or for anything else.
2. Members of the Rustenburg CPF must be a resident and/or working and/or own a business in the Rustenburg station area.
3. No person residing in another area may be a member of the Rustenburg Exco/Sector Committee/Sub Forum Committee.
4. Membership of the Rustenburg CPF is open to all bona fide community-based organizations, faith-based organizations, non-governmental organizations, formal and informal business organizations and other social organizations which serve the Community with a good standing, registration is done with the Rustenburg Exco and with approval from the Rustenburg Exco.
5. Membership of the Rustenburg CPF is open to all interested individuals with a good standing, registration is done with the Sector or Sub Forum and with approval from the Sector or Sub Forum with regards to 2. & 3..
6. Membership of the Rustenburg CPF is open to all interested individuals with no Serious Criminal Record.
7. Individuals shall register for membership of the Rustenburg CPF by completing the Sector/Sub Forum membership application form of the Rustenburg CPF.
8. Members from a Neighborhood/Plot/Farm Watch or Street Watch etc, who wants to become a CPF Member will first and foremost be a CPF member and secondly a member of his/her original organization.
9. Neighborhood/Plot/Farm/Street Watches/Organizations/Security companies shall register for membership of the Rustenburg CPF by completing the applicable registration application form of the Rustenburg CPF.
10. Members must endeavor to attend all Rustenburg CPF meetings relevant to their membership.
11. The Sector/Sub Forum may decline a potential CPF member membership after consideration of such an application, if the potential CPF member is not satisfied with the decision of the Sector/Sub Forum in declining his/her membership then the proper appeal process needs to be followed,
12. The Sectors shall, as far as practically possible, be represented on the Exco by two members.
13. The Exco, at its discretion, may co-opt. additional members from the Sectors/Sub Forums as required for their skills.
14. No membership fee shall be payable.

This MEMBERSHIP POLICY shall be effective from the date of approval and signature by the Members of Executive Committee
